




ADMINISTRATIVE ORDER NO. 2009-03

Therefore, good cause appearing,

IT IS HEREBY ORDERED that Magistrate Judges Stephen Calhoun, Jeff Payne, and Randall Robinson be, and hereby are, APPOINTED as pro tem District Judges for the purpose of presiding over arraignments and initial appearances on probation violations in Clearwater, Idaho, and Lewis counties.

IT IS FURTHER ORDERED that the appointments of Magistrate Judges Stephen Calhoun, Jeff Payne, and Randall Robinson are subject to the coordination of their personal court calendars.

IT IS FURTHER ORDERED that the appointments pursuant to this Order shall be for the period listed below:

May 4, 2009 through May 29, 2009,
unless otherwise provided by an order of this Court.

IT IS FURTHER ORDERED that the reporting of any proceeding assigned to Magistrate Judges Calhoun, Payne, and Robinson may be by an electronic recording as the official record in lieu of a court reporter as determined by the Judges.

IT IS FURTHER ORDERED that a copy of this Order shall be placed in the pro tem judge assignments file to be maintained by the District Court Clerk as a central register of all assignment orders.
