ORDER DESIGNATING
CUSTODIAN JUDGES
OF JUDICIAL RECORDS

Rule 32, I.C.A.R. having delegated to the Administrative District Judge the authority to designate Custodian Judges for judicial records within the judicial district, the undersigned Administrative District Judge HEREBY ORDERS:

(1) that for records in a case file in the District Court, the Custodian Judge is the presiding judge or magistrate of that case, and in the event of that judge's or magistrate's unavailability to rule upon a request for the examination or copying of a judicial record within the time limits allowed by Rule 32, I.C.A.R., then

- (a) any District Judge within the District shall be authorized to rule on such a request for any unavailable District Judge or Magistrate; and
- (b) any Magistrate Judge within the District shall be authorized to rule on such a request for any unavailable Magistrate Judge;

(2) that for records not in a case file in the District Court, the Custodian judge shall be either the Administrative District Judge, a resident District Judge in the county of origin of the particular record(s) requested, or a resident Magistrate Judge of the county of origin, where there is no resident District Judge or where none is available within the time limits allowed by Rule 32, I.C.A.R.

IT IS FURTHER ORDERED that copies of this Order shall be posted in all counties within the Second Judicial District


